Manufacturer's Certification Statement Regarding Eligible Building Envelope Components for The American Recovery and Reinvestment Act of 2009

Amerimax Vinyl Windows, located at 3950 Medford Drive in Loveland, CO 80538 and 1660 Tide Court in Woodland, CA 95776, is the manufacturer of Amerimax Vinyl Windows and Patio Doors.

This certificate applies to only Amerimax manufactured products and serves as verification that the products listed in this document qualify for the Federal Energy Tax Credit by having both a U-Factor of equal to or less than 0.30 and a Solar Heat Gain Coefficient (SHGC) equal to or less than 0.30.

Qualifying Amerimax Products:

The Amerimax products as listed in this document meet or exceed the residential energy efficiency criteria established by passing of The American Recovery and Reinvestment Act of 2009 and are considered Eligible Building Envelope Components that qualify for federal income tax credit as allowed by Internal Revenue Code Section 25C.

Taxpayers claiming a credit for an Eligible Building Envelope Component should save the purchase receipt with tax documents along with this certification statement as part of the taxpayer's records. **Installation of the qualifying products must occur between February 17, 2009 and December 31, 2010.**
