

## RECREATIONAL VEHICLE DOOR WARRANTY

Amerimax Building Products, Inc. warrants to the original purchaser that each recreational vehicle door delivered hereunder will be free of defects in material and workmanship for a period of one (1) year from the date the vehicle in which it is installed is sold at retail, or two (2) years from the date the doors are sold to the vehicle manufacturer, whichever comes first. The sole and exclusive remedy with respect to this warranty or with respect to any other claim relating to defects or any other condition or use of the products supplied by Amerimax, however caused, and whether such claim is based upon warranty, contract, negligence, strict liability or any other theory, is limited to repair or replacement of such products subject to Amerimax's RV Door Flat Rate Repair Labor and Warranty Parts Schedule, or repayment by Amerimax of the purchase price paid to it.

This warranty is subject to the following conditions:

- 1. doors must be installed and maintained according to the installation instructions published by Amerimax;
- 2. this warranty specifically excludes any discoloration of fiberglass exterior skins due to ultraviolet exposure;
- 3. this warranty specifically excludes doors installed in vehicles used for commercial purposes or for rental;
- 4. this warranty excludes adjustments of any type to door cores, screen doors, door frames, etc;
- 5. Amerimax must be notified in writing within thirty (30) days after such purported defect appears.

This warranty also does not cover, and Amerimax hereby disclaims all liability for, any product which has been subject to abuse, alteration, modification, neglect, misuse, abnormal use, accident, fire, flood, earthquakes, acts of God, or to which parts, not supplied by Amerimax, have been added, or to defects caused by depreciation or normal wear. All decisions regarding the existence of defects in material and workmanship and the occurrence of any of the conditions described in the preceding paragraphs or affecting this Warranty shall be made by Amerimax and shall be final and binding upon the parties. This Warranty is tendered for the sole benefit of the original purchaser and is not transferable or assignable.

THIS WARRANTY IS IN PLACE OF ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, STATUTORY OR OTHERWISE, AND ALL IMPLIED WARRANTIES, INCLUDING WITHOUT LIMITATION THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS OF PURPOSE, ARE HEREBY DISCLAIMED. SOME STATES DO NOT ALLOW THE ABOVE LIMITATIONS OF THE APPLICABILITY OF AN IMPLIED WARRANTY, SO THE ABOVE LIMITATIONS MAY NOT APPLY TO YOU. IN CONSIDERATION OF THIS WARRANTY, THE ORIGINAL PURCHASER AGREES THAT AMERIMAX SHALL NOT BE LIABLE FOR ANY INCIDENTAL DAMAGES (INCLUDING GLASS BREAKAGE NOT RESULTING FROM DEFECT OR MALFUNCTION), OR SPECIAL OR CONSEQUENTIAL DAMAGES IN CONNECTION WITH THE USE OF, OR THE INABILITY TO USE, THE DOORS. SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTIAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS. YOU ALSO MAY HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE. The suitability of a product for an intended use shall be the sole responsibility of the user. Amerimax Building Products' liability shall in no event exceed the purchase price of the product supplied by it. No person has the authority to change these terms and there are no warranties except as stated herein.
